REQUEST FOR PROPOSAL

SCOPE OF WORK

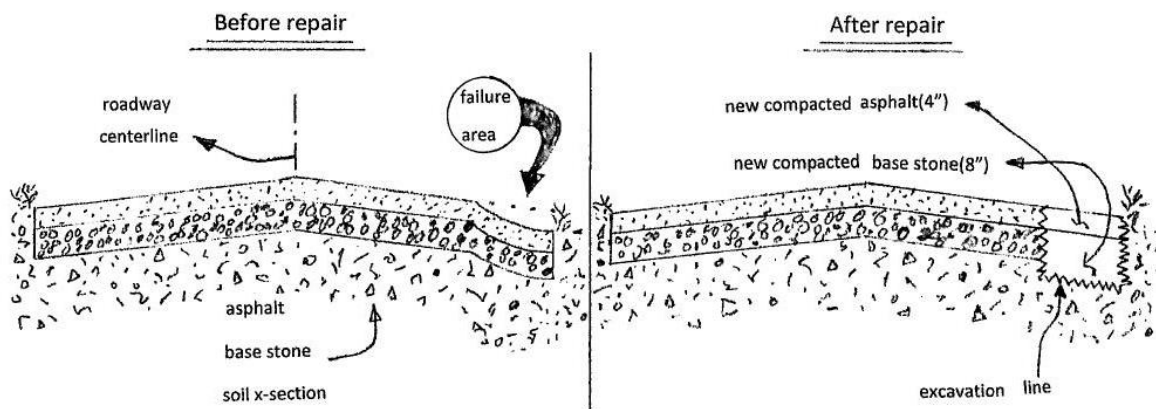
The work involves the partial repair of the roadways of the Hamblen County Road System and will be confined in the roadway from one edge of pavement to the other.

PROCEDURE

The work will fall into one of two types of repair, **Type "A"** repair or **Type "B"** repair. The Hamblen County Road Superintendent will mark the roadway with white paint to designate those areas needing repair. A **Type "A"** repair will involve the excavation of approximately one (1) foot of materials including old asphalt, old base stone, and weak existing soil followed by the placement and compaction of eight (8) inches of base stone and four (4) inches of new asphalt (c-mix gradation). A sketch of a **Type "A"** repair is shown below. A **Type "B"** repair will involve the removal of a broken or extremely worn area of asphalt that will be from 1 (one) to 4 (four) inches in depth, whereby, new asphalt will be placed and compacted back in that same area. The work will be paid for by the square yard unit of measure.

The Hamblen County Road Superintendent, in cooperation with the contractor, will determine those areas beyond the normal **Type "A"** repair and deploy the personnel of the Hamblen County Highway Department to complete those repairs.

A cross-sectional sketch of a repair area is shown below:



PRE-CONSTRUCTION MEETING (before a contractor is selected)

A meeting with any interested parties will be conducted by the Hamblen County Road Superintendent upon request to inspect the condition of the road(s) and clarify any details regarding the project.

RESPONSIBILITY OF THE CONTRACTOR

- To complete a location of all the utilities within the right-of-way.
- Furnish the labor, materials, equipment, and vehicles needed to complete the repairs.
- Properly dispose of the waste materials.
- Maintain a drug-free workplace.
- Maintain liability and workers compensation insurance as required by the laws in the State of Tennessee.
- Maintain traffic control as specified by the “Manual on Uniform Traffic Control Devices”.
- Be licensed by the State of Tennessee and have relevant experience with roadwork, asphalt placement, materials compaction, etc...
- The finished product of the repair must ride smoothly to accommodate the traveling public until the resurfacing takes place.

METHOD OF PAYMENT

The contractor will be paid by the **square yard** measurement for both the **Type “A” and Type “B”** areas of repair. A “Proposal” will include a price for both types of repairs. The final measurement for payment will be made together by a representative from the Hamblen County Highway Department and a representative of the awarded Contractor.

PROPOSAL DUE DATE

Proposals will be accepted until 2:00 pm on Tuesday, February 11, 2020
